



# Rigorous Quality and Allergen Testing

Seed conducts extensive verifications on DS-01®, including a suite of third-party testing throughout the manufacturing process. Their battery of tests includes:

- Potency (AFU)<sup>†</sup>
- Survivability (SHIME®)
- · Contaminants (heavy metals and pesticides)
- Extended allergen panel (all 14 EFSA-defined classes)
- Thermostability (temperature)
- · Whole-genome sequencing

With 50+ quality assurance and quality control (QA/QC) checkpoints, they monitor purity under both U.S. and European protocols (including cGMP and HACCP) throughout the production cycle. This means they extensively test each ingredient batch prior to encapsulation, and each batch after manufacture.
